Big Ticket Sweepstakes November 14, 2024 – December 13, 2024 Official Rules

LIMIT ONE (1) ENTRY, PER PERSON. Sponsor's computer will be the official timekeeper for all matters related to this Sweepstakes. The use of automated devices to enter this Sweepstakes is prohibited. Entries generated by script, macro or other automated or mechanical means and entries generated by any other means which subvert the entry process will be void. Any attempt by any person to obtain more than the stated number of entries will void all of that person's entries and that person will be disqualified.
